**Canton Fine Arts Associates, Inc.**, an all-  
volunteer affiliate organization of the Museum.  
The show takes an entire year of planning and  
work, using approximately 5200 volunteer hours.  
Since its inception in 1952, Canton Fine Arts has  
raised \$1.5 million for the Museum.

The **Canton Museum of Art** is Stark County's  
home for fine art and is accredited by the  
American Association of Museums. CMA's  
nationally recognized Permanent Collection  
contains over 1,200 pieces focusing on 19<sup>th</sup> and  
20<sup>th</sup> Century American watercolors and works on  
paper, as well as an outstanding collection of  
contemporary ceramics.

In its 75 years of existence, the Museum has  
featured numerous noteworthy exhibits from  
artists including Norman Rockwell, Andrew  
Wyeth, Clyde Singer, and Itchiku Kubota.

## BOOTH INFORMATION

**Artist Must Be Present:** Representatives  
may not participate in place of the artist  
during Christkindl Markt.

**Vendor's License:**  
A current vendor's license is required.

**Booth Fees:**  
\$300 for approx 8 x 10 booth space  
\$440 for approx 8 x 15 booth space  
These larger spaces are very limited.

The Booth Fee includes the  
Canton City Income Tax.

- Booth Requirements:**
- \* The Markt is inside a building. It cannot accommodate tents or canopies.
  - \* Each single booth is approximately 10' across and 8' deep.
  - \* Your booth must be accommodating as we have many structural features to work around (permanent benches, pillars, walls, etc.).
  - \* Your booth may be in an open area where there are no walls. In that case, you will need self-sustaining dividers.
  - \* We do not provide tables.
  - \* Electricity is limited to 500 watts per booth.
  - \* **You must bring your own lights.**
  - \* Bulbs cannot be over 75 watt/120 volt.
  - \* Electrical cords that you bring must be heavy duty electrical cords.
  - \* You must bring a 2 ½ # (or larger) ABC Fire Extinguisher.
  - \* No open flames, no burning candles.

## ORIGINAL WORK

All work must be original and handcrafted by the artist.  
**No Buy/Sell or Imports Allowed**

### **Definitions of Categories**

- Candles/Wax – Original work designed by artist.  
Ceramics/Pottery – Original work, decorative or functional.  
Christmas Items – Original work designed by the artist including Santas, florals, and ornaments.  
Drawing/Pastel – Original work made with pen, pencil, charcoal, pastel, or chalk.  
Fiber/Wearables – Original work in fiber including soft sculpture, batik, painted fabric, baskets.  
Floral – Original work designed by artist.  
Glass – Original work where the primary material is glass. No manufactured molds or other mass production.  
Graphics/Printmaking – Prints of original work done by the artist, by traditional methods including etching, engraving, silkscreen, stone and plate lithography, linoleum block or woodcut.  
Jewelry – Original jewelry made from precious and non-precious metals, gemstones, enamel, glass, clay, fiber, etc.  
Leather – Original work, decorative or functional.  
Metal – Original work designed by artist.  
Painting – Original work in oils, acrylics, and watercolor.  
Photography – Original photos taken by the artist.  
Sculpture – Original nonfunctional 3-D work of any material.  
Wood – Original work, carved or turned, decorative or functional. Includes furniture.

**Application Criteria:**  
 Exhibitors may exhibit work only in the category (or categories) for which the jury accepted them.

Exhibitors must apply separately for each category, with a maximum of two categories.

Two Exhibitors may share a booth but **both** Exhibitors must apply and be accepted.

**Application Fee:** A \$20.00 non-refundable application fee is due with each application submitted. Make check payable to Christkindl Markt. No Credit Cards please.

**Resume and List of Shows:**  
 Attach a resume, a list of the shows in which you have participated, and a list of awards you have received.

**Images of Your Work:** Five (5) digital images (JPG format, 800 pixel x 600 pixel on a CD) will be the basis for the jurying process. Submit four close-ups, each showing only one piece of art, and one close-up of your booth with items of your work displayed. (If you submit more than five images, only the first five will be used.) Your digital images must represent the items to be shown at Christkindl Markt. Label your CD with your name.

A separate color photograph of your booth is also required (for our records only – it will not be returned).

**Deadlines:**  
 Application and Application Fee: **3-15-12**  
 Include a Self Addressed Stamped Envelope for the return of your CD.  
 Booth Fee: After receipt of acceptance letter and before **6-30-12**  
 Late Payment Fee: \$20.00  
 Cancellation Fee: \$ 20.00 after **8-31-12**  
 Forfeiture of booth for non-payment: **9-15-12**
